By motion of Nousiainen supported by Cane and carried to approve the agenda.





RESOLUTION 2022-13

ONTONAGON COUNTY FIVE-YEAR RECREATION PLAN 2023-2027

WHEREAS, the Ontonagon County has undertaken a planning process to determine the recreation and natural resource conservation needs and desires of its residents during a five-year period covering the years 2023 through 2027, and

WHEREAS, Ontonagon County began the process of developing a community recreation plan in accordance with the most recent guidelines developed by the Department of Natural Resources and made available to local communities, and

WHEREAS, residents of Ontonagon County were provided with a well-advertised opportunity during the development of the draft plan to express opinions, ask questions, and discuss all aspects of the recreation plan, and

WHEREAS, the public was given a well-advertised opportunity and reasonable accommodations to review the draft plan for a period of at least 30 days, and

WHEREAS, a public hearing was held on December 20, 2022 at the Ontonagon County Courthouse to provide an opportunity for all residents of the planning area to express opinions, ask questions, and discuss all aspects of the Ontonagon County Five-Year Recreation Plan 2023-2027, and

WHEREAS, the Ontonagon County Board of Commissioners has developed the plan as a guideline for improving recreation and enhancing natural resource conservation for the Ontonagon County, and

WHEREAS, after the public hearing, the Ontonagon County Board of Commissioners voted to adopt said Ontonagon County Five-Year Recreation Plan 2023-2027.

NOW, THEREFORE BE IT RESOLVED the Ontonagon County Board of Commissioners hereby adopts the Ontonagon County Five-Year Recreation Plan for 2023-2027.


