- Section 8 "Exemption" Option a local unit of government, as defined in the Act, may exempt itself from the requirements of the Act by annual 2/3 vote of the governing body;

WHEREAS, the Ontonagon County Board of Commissioners has decided to adopt the annual Exemption option as its choice of compliance under the Act;

NOW, THEREFORE, BE IT RESOLVED the Ontonagon County Board of Commissioners elects to comply with the requirements of 2011 Public Act 152, the Publicly Funded Health Insurance Contribution Act, by adopting the annual Exemption option for the medical benefit plan coverage for calendar year 2022.

NOW THEREFORE BE IT RESOLVED that the Ontonagon County Board of Commissioners supports enactment of HB 5026 to ensure continued operation and funding of 9-1-1 service.
